**EXECUTIVE ORDER
(No. 13 Series of 2021)**

**AN ORDER ORGANIZING THE HEARTS VILLAGE MANAGEMENT COUNCIL
FOR HOUSING PROGRAM AT SITIO STO. NIÑO, BARANGAY MALITBOG,
BONGABONG ORIENTAL MINDORO, DEFINING ITS COMPOSITION,
FUNCTIONS AND OTHER ATTENDANT REGULATIONS**

WHEREAS, pursuant to Republic Act 7279, otherwise known as the Urban Development and Housing Act of 1992, and its Implementing Rules and Regulations (IRR), prescribes the relocation of families from temporary settlement to permanent resettlement within one-year;

WHEREAS, Pursuant to Sec. 18 of the Republic Act No. 7279 or the Urban and Development Housing Act of 1992, eviction or demolition may be allowed under the following situations: *when persons or entities occupy danger areas such as esteros, railroad tracks, garbage dumps, riverbanks, shorelines, waterways, and other places such as sidewalks, roads, parks, and playgrounds; when government infrastructure projects with available funding are to be implemented; or when there is a court order for eviction or demolition.*

WHEREAS, the local Government Unit of Bongabong has a housing program located at So. Sto. Niño, Malitbog, Bongabong, Oriental Mindoro.

WHEREAS, the beneficiaries of the said housing program are those households who have been affected by the massive road clearing operations pursuant to DILG Memorandum Circular 2019-121 and other displaced households in the municipality.

NOW, THEREFORE, I, ELEGIO A. MALALUAN, O.D., by virtue of the powers vested in me as the Mayor of the Municipality of Bongabong do hereby constitute the HEARTS Village Management Council for Housing Programs and define its composition, functions and sub-committees as follows:

SECTION 2. Duties and Functions.

- a. Prepare and endorse to the approving authority (LCE) the final list of qualified beneficiaries;
- b. Arbitrate and resolve census-related appeals and disputes such as but not limited to the following:
 - i. Appeals for inclusion in the census master list/registry of households;
 - ii. Appeals for reconsideration of status such as absentee house owners, out during census, and those who refused to be interviewed;
 - iii. Petitions for revocation of qualified status due to misrepresentation or guidelines violations; and
 - iv. Rectification of household's basic information;
- c. Prepare the appropriate resolution on all petitions, appeals and census claims for endorsement to the approving authority;
- d. Formulate and implement policies and guidelines for the member-beneficiaries of the Hearts Village;
- e. Review, revise, and update policies and guidelines stipulated in "Gabay sa Paninirahan";
- f. Monitor housing incident cases reported by homeowners association;
- g. Conduct random inspection on housing units if necessary;
- h. Other duties authorized by other higher authorities

SECTION 3. Secretariat

The MPDO shall act as Secretariat that will provide technical assistance and administrative support to the Council.

SECTION 4. REPEALING CAUSE

All rules and regulations, executive orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion thereof, are hereby repealed or modified accordingly.

SECTION 5. SEPARABILITY CLAUSE

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

SECTION 6. EFFECTIVITY

This Executive Order shall take effect immediately and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
