EXECUTIVE ORDER

(No. 18 Series of 2021)

AN ORDER ALLOWING CHANGES TO THE INDIVIDUAL PROJECT PROCUREMENT MONITORING PLAN (PPMP), ANNUAL SUPPLIES PROCUREMENT PLAN (ASPP), AND CONSOLIDATED ANNUAL PROCUREMENT PLAN (APP)

WHEREAS, the offices of the Local Government Unit of Bongabong submitted to the Municipal Budget Office the indicative PPMPs and ASPPs in October 2020 for the Fiscal Year 2021 for consolidation of the indicative Annual Procurement Plan by the Bids and Awards Committee;

WHEREAS, Section 11 of R.A. 9184 authorizes the Head of the Procuring Entity (HOPE) to delegate procurement-related responsibilities subject to the limitations provided by the law;

WHEREAS, Section 7.4 of the said IRR allows changes to the individual PPMPs, ASPPs, and consolidated APP as often as required by the Head of the Procuring Entity

WHEREAS, the respective end-user or implementing units of the procuring entity shall be responsible for the changes to the PPMPs, while the BAC Secretariat shall be responsible for the consolidation of these PPMPs into APP for approval of the HOPE;

NOW, THEREFORE, I, ELEGIO A. MALALAUAN, O.D., Municipal Mayor of Bongabong, Oriental Mindoro by virtue of the powers vested in me by law, do hereby promulgate this order to allow changes to the Individual Project Procurement Monitoring Plan (PPMP), Annual Supplies Procurement Plan (ASPP), and consolidated Annual Procurement Plan (APP).

This Executive Order shall take effect immediately and shall remain enforced, unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
