**EXECUTIVE ORDER
(No. 28 Series of 2021)**

**AN ORDER DESIGNATING THE TRAFFIC MANAGEMENT OFFICE AS AN
AUXILIARY RESCUE TEAM FOR THE MUNICIPAL DISASTER RISK
REDUCTION AND MANAGEMENT OFFICE FOR THE MUNICIPALITY OF
BONGABONG, ORIENTAL MINDORO**

WHEREAS, Section 444 of Republic Act 7160, provides that one of the functions of the Municipal Mayor shall issue Executive Orders as necessary for the proper enforcement and execution of laws;

WHEREAS, there is a necessity to adopt a disaster risk reduction and management approach that is comprehensive, integrated, and proactive in lessening the socioeconomic and environmental impacts of disasters including climate change, and promote the involvement and participation of all civil sectors, all stakeholders concerned, and the community;

WHEREAS, Section 12 of Republic Act No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 provides that LDRRMOs and the BDRRMCs shall organize, train and directly supervise local emergency response teams;

WHEREAS, there is a need to supplement the current responder team of MDRRMO of the Municipality of Bongabong to abide by the required number of personnel needed for an effective response team to provide effective rescue for the number of population in a first class Municipality such as the Municipality of Bongabong;

NOW THEREFORE, I, ELEGIO A. MALALUAN O.D., MUNICIPAL MAYOR OF THE MUNICIPALITY OF BONGABONG, by virtue of the power vested in me do hereby order:

Section 1. The Designation of the Traffic Management Office as an Auxiliary Rescue Team for the Municipality of Bongabong, Oriental Mindoro.

Section 2. REPEALING CAUSE. All previous Orders, Memorandum, Circulars, Directive, Instructions issued by the Municipal Mayor which are inconsistent with this Order are hereby modified, amended and / or repealed accordingly.
