EXECUTIVE ORDER
(No. 04 Series of 2021)

**AN ORDER MANDATING THE CREATION OF THE IMPLEMENTING TEAM
OF THE RPRH LAW IN THE MUNICIPALITY OF BONGABONG**

WHEREAS, Republic Act No. 10354, otherwise known as the "Responsible Parenthood and Reproductive Health Act of 2012 (RPRH Law), recognizes the right of the Filipinos to decide freely and responsibly on their desired number of spacing and children, within the context of responsible parenthood and informed choice, and to access needed reproductive health care information and services;

WHEREAS, to intensify and accelerate implementation to attain and sustain "Zero Unmet Need for Modern Family Planning," the President issued Executive Order No. 12 Series of 2017 entitled, "Attaining and Sustaining Zero Unmet Need for Modern Family Planning' through the Strict Implementation of the Responsible Parenthood and Reproductive Health Act";

WHEREAS, in compliance to Responsible Parenthood and Reproductive Health law and its IRR, a Municipal Implementing Team (MIT) for the RPRH Law needs to be created.

NOW THEREFORE, I, ELEGIO A. MALALUAN, O.D., Municipal Mayor of Bongabong, Oriental Mindoro, by virtue of powers vested in me by law, do hereby order the creation of the **MUNICIPAL IMPLEMENTING TEAM (MIT) FOR RPRH LAW IN THE MUNICIPALITY OF BONGABONG** which shall be constituted to perform its assigned duties and functions.

Section 2. DUTIES AND FUNCTIONS

A. The Municipal Implementing Team (MIT) for Responsible Parenthood and Reproductive Health shall have the following duties and functions:

1. Design a program for the implementation of the RPRH Law at the municipal level, specifying the required technical, financial, and logistical support for its implementation;
2. Ensure the integration of the RPRH Law in the functions and activities of the agencies/organizations that they represent;
3. Formulate policies necessary to promote the Programs on Population and Family Planning which will cater the basic needs of both men and women in the municipality;
4. Coordinate with agencies tasked to implement the RPRH Law and monitor its implementation at the municipal level, and;
5. Provide the LCE with regular reports on the status of the implementation of the RPRH Law at the municipal level and come up with recommendations to address the gaps, if there be any.

B. The Secretariat

There shall be a Secretary who shall be responsible for providing technical and administrative support to the Team, draft the necessary letters/correspondence, document meetings and operation proceedings including photos, and to do research and provide relevant/needed information to aid the Team.

Section 3. REPEALING CAUSE

All rules and regulations, executive orders, office orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion hereof, are hereby repealed or modified accordingly.

Section 4. SEPARABILITY CLAUSE

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

Section 5. EFFECTIVITY

This Executive Order shall take effect immediately and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
