AN EXECUTIVE ORDER REORGANIZING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC), REORGANIZING THE SECTORAL COMMITTEES AND ITS TECHNICAL WORKING GROUP

WHEREAS, the Municipal Development Council of the Municipality of Bongabong has already been constituted pursuant to the mandate of the Local Government Code of 1991;

WHEREAS, the recently-concluded local elections caused changes to the set of public officials who composed the MDC;

WHEREAS, the accredited Civil Society Organizations (CSOs)/Non-Government Organizations (NGOs) operating in the municipality shall be selected during the Organizational/Selection of Representatives to Local Special Bodies of the Municipality of Bongabong;

WHEREAS, the foregoing intervening events require the reorganization of MDC of Bongabong, Oriental Mindoro;

WHEREAS, the MDC reorganization will set the direction towards a sustainable economic and social development, and will synchronize development efforts within the municipality under the present administration;

NOW THEREFORE, I, ELEGIO A. MALALUAN, Municipal Mayor of the Municipality of Bongabong, Oriental Mindoro, by virtue of the powers vested in me by Section 444 (b)(2)(iii) Article One, Chapter 3, Book III of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, do hereby promulgate this Executive Orders as follows:

Section 1. REORGANIZATION

Section 2. DUTIES AND FUNCTIONS.

A. The MDC shall perform the following functions:

- Formulate long-term, medium term and annual socio-economic development plans and policies;
- Formulate medium-term and annual public investment programs;
- Evaluate and prioritize socio-economic development programs and projects;
- Formulate local investment incentives to promote the inflow and direction of private investment capital;
- Coordinate, monitor and evaluate the implementation of development programs and projects; and
- Perform such other functions as may be provided by law or component authority.

B. The Sectoral Committees shall perform the following functions:

- Conduct sectoral/inter-sectoral analysis, validation and reports
- Conduct of surveys, consultation meetings, workshops
- Integration/finalization of studies, research findings, and consultation/survey outputs
- Identify recommended programs, projects, and activities to the Municipal Development Council.

C. The Technical Working group:

- Shall assist the Sectoral Committees during the planning process
- Shall provide technical and administrative support, prepare reports
- Provide such other assistance as may be required by the MDC.

Section 3. MUNICIPAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE.

- a. There shall be an Executive Committee in the MDC who shall act on its behalf when it is not in session.

b. the EXECOM shall be composed of the following:

c. The EXECOM shall exercise the following powers and functions:

1. Ensure that the decision of the council is faithfully carried out and implemented;
2. Act on matters requiring immediate attention or action by the council;
3. Formulate policies, plans and programs based on the general principles laid down by the council; and
4. Act on matters that may be authorized by the council.

Section 4. MEETINGS. The MDC shall meet at least once every six (6) months or as often as may be necessary.

Section 5. SECRETARIAT.

- a. The secretariat of the MDC shall be headed by the Municipal Planning and Development Coordinator and selected partners from CSO/NGO/NGA/Academe as members.
- b. The secretariat shall perform the following functions:
 1. Responsible for the provision of technical supports;
 2. Documentation of proceedings;
 3. Preparation of reports; and
 4. Perform such other functions as may be required in the discharge of its functions.

Section 6. REPEALING CAUSE

All rules and regulations, executive orders, office orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion hereof, are hereby repealed or modified accordingly.

Section 7. SEPARABILITY CLAUSE.

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

Section 8. EFFECTIVITY.

This Executive Order shall take effect immediately and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
