**AN EXECUTIVE ORDER REORGANIZING THE EXPANDED LOCAL HEALTH BOARD  
OF THE MUNICIPALITY OF BONGABONG**

**WHEREAS**, Section 102 of the Local Government Code Of 1991 provides for the mandatory creation of Local Health Board in every local government unit;

**WHEREAS**, there is a need to ensure the delivery of basic services and health programs in the LGU;

**WHEREAS**, there is a need for an efficient, effective and economical implementation of health services program geared to implement health-related projects and activities;

**WHEREAS**, the chairperson, vice chairperson and members of the local health board shall perform their duties as such without compensation and remuneration;

**WHEREAS**, members who are not government officials or employees shall be entitled to necessary traveling expenses and allowances chargeable against the funds of the local health board subject to existing accounting and auditing rules and regulations;

**NOW THEREFORE**, I, **ELEGIO A. MALALUAN**, Mayor of the Municipality of Bongabong, by virtue of the powers vested in me by law, do hereby order the reorganization of the Expanded Local Health Board.

**SECTION 1. REORGANIZATION AND COMPOSITION.** The Expanded Local Health Board is hereby reorganized to be composed of the following:

**SECTION 2. FUNCTIONS.** The Local Health Board shall perform the following functions:

- (1) To propose to the Sanggunian Bayan, in accordance with standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services;
- (2) To serve as an advisory committee to the Sanggunian Bayan on health matters such as, but not limited to, the necessity for, and application of local appropriations for public health purposes; and
- (3) Consistent with the technical and administrative standards of the Department of Health, create committees which shall advise local health agencies on matters such as,

but not limited to, personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review, operations review and similar functions.

### **SECTION 3. MEETINGS AND QUORUM**

(1) The Local Health Board shall meet at least once a month or as often as may be deemed necessary.

(2) A majority of all its members shall constitute a quorum but the chairman or the vice-chairman must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approve such proposals.

### **SECTION 4. SECRETARIAT.**

The Municipal Health Office, thru Ms. Pinky Gabay-Trivinio, shall serve as the Secretariat and shall be responsible in coordinating the activities of the Council.

### **SECTION 5. REPEALING CAUSE**

All rules and regulations, executive orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion thereof, are hereby repealed or modified accordingly.

### **SECTION 6. SEPARABILITY CLAUSE**

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

### **SECTION 7. EFFECTIVITY**

This Executive Order shall take effect immediately and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
