EXECUTIVE ORDER (No. 39 Series of 2022)

AN ORDER UPDATING THE MUNICIPAL INTER-AGENCY COMMITTEE (MIAC)
FOR THE IMPLEMENTATION OF THE THREE (3) CORE PROGRAMS OF THE
DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD): (1) THE
KAPIT-BISIG LABAN SA KAHIRAPAN – COMPREHENSIVE AND INTEGRATED
DELIVERY OF SOCIAL SERVICES (KALAHI-CIDSS) PROJECTS, (2) PANTAWID
PAMILYANG PILIPINO PROGRAM AND (3) SUSTAINABLE LIVELIHOOD
PROGRAM (SLP)

WHEREAS, the Department of Social Welfare and Development is implementing the three cores social protection programs namely: Pantawid Pamilyang Pilipino Program, KALAHI-CIDSS, and the Sustainable Livelihood Program in the Municipality of Bongabong, Oriental Mindoro;

WHEREAS, the core programs aim for the local community to have a continuing access to basic needs and social services. Thus, community members are empowered and participative in community-based protective services and assessment towards poverty reduction;

WHEREAS, there is a call for convergent action to maximize, harmonize and synchronize the processes involved and resources allocated for the implementation of the social protection programs to reduce duplication of efforts strategies of DSWD workers, and develop partnership among its agencies for realization of this strategy at the local/municipal level where the beneficiaries are located;

WHEREAS, there is a need to create a Municipal Inter-Agency Committee (MIAC), which will serve as partners in the implementation of the three (3) core programs of the DSWD in the Municipality of Bongabong, Oriental Mindoro;

NOW THEREFORE, I, ELEGIO A. MALALUAN, Local Chief Executive of the Municipality of Bongabong, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Municipal Inter-Agency Committee (MIAC) for the implementation of the three (3) core programs of the Department of Social Welfare and Development (DSWD): the Kapit-Bisig Laban sa Kahirapan – comprehensive and integrated delivery of social services (KALAHI-CIDSS) projects, Pantawid Pamilyang Pilipino Program and Sustainable Livelihood Program (SLP);

SECTION 2. DUTIES AND FUNCTIONS.

The following shall be the duties and functions of the Municipal Inter-Agency Committee (MIAC):

- Assist in the development of sustainable poverty reduction programs for the beneficiaries of Pantawid Pamilya, KALAHI-CIDSS, and SLP in Bongabong, Oriental Mindoro.
- Assist in the implementation of program operation plans in terms of membership mobilization, education, and training, accounting, records keeping, financial recording, funds management and overall management.
- Provide updates, determine issues and concerns and identify possible recommendations for the smooth implementation of the programs.
- Provide limited funding and technical support in the implementation of 3 core programs of DSWD in the municipality of Bongabong, Oriental Mindoro.
- Assist in monitoring the implementation of projects identified during Bottom-Up Planning and Budgeting (BUPB) initiated by the National Anti-Poverty Commission.
- Attend quarterly meetings set by the Committee Chairman.

SECTION 3. REPEALING CAUSE

All rules and regulations, executive orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion thereof, are hereby repealed or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

SECTION 5. EFFECTIVITY

This Executive Order shall take effect immediately and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
