EXECUTIVE ORDER NO. 48 Series of 2022

AN EXECUTIVE ORDER REORGANIZING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC)

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that every local government unit shall ensure, among others, maintain peace and order and preserve the comfort and convenience of their inhabitants;

WHEREAS, the threat of illegal drugs must be addressed much more effectively to help ensure community peace and harmony;

WHEREAS, DILG Memorandum Circular No. 98-227 dated December 02, 1998, mandates the creation of Anti-Drug Abuse Council in every province, cities, municipalities, and barangay;

NOW, THEREFORE, I, ELEGIO A. MALALUAN, O.D., Municipal Mayor of Bongabong, Oriental Mindoro, Philippines by virtue of the powers vested in me, do hereby reorganize the Municipal Anti-Drug Abuse Council as follows;

SECTION 1. REORGANIZATION OF THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL.

SECTION 2. Rules and Responsibilities of the Municipal Anti-Drug Abuse Council (MADAC).

- 1. Serve as a focal point through which various organizations and individuals work together cooperatively in the planning. Implementation and evaluation of programs on drug abuse prevention;
- 2. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future;
- **3.** Provide for s mechanism to obtain funds volunteers facilities and technical and expertise;
- **4.** Perform other related responsibilities as may be assigned by competent authorities.

SECTION 3. FUNDING. Funding shall be provided by the Municipal Government to support the programs as per Executive Order No. 250, dated May 24, 2000 which state "Amending Section 1 of Executive Order No. 189 date December 21, 1999 entitled, directing all Local Government Units to submit to the Department of Budget and Management their respective "Annual Investment Plan". The said amendatory Executive Order mandates that no less than 5% of the 20% Development Fund shall be appropriated for anti-illegal activities at the local level.

SECTION 4. REPEALING CLAUSE. All rules and regulations, executive orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion thereof, are hereby repealed or modified accordingly.

SECTION 5. SEPARABILITY CLAUSE. If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
