**EXECUTIVE ORDER**  
(No. 01 Series of 2023)

**AN EXECUTIVE ORDER REORGANIZING THE MUNICIPAL IMPLEMENTING TEAM  
OF THE RESPONSIBLE PARENTHOOD AND REPRODUCTIVE HEALTH (RPRH)  
LAW IN THE MUNICIPALITY OF BONGABONG**

**WHEREAS**, Republic Act No. 10354, otherwise known as the "Responsible Parenthood and Reproductive Health Act of 2012 (RPRH Law), recognizes the right of Filipinos to decide freely and responsibly on their desired number of spacing and children, within the context of responsible parenthood and informed choice, and to access needed reproductive health care information and services;

**WHEREAS**, to intensify and accelerate implementation to attain and sustain "Zero Unmet Need for Modern Family Planning," the President issued Executive Order No. 12 Series of 2017 entitled, "Attaining and Sustaining Zero Unmet Need for Modern Family Planning' through the Strict Implementation of the Responsible Parenthood and Reproductive Health Act";

**WHEREAS**, in compliance with the Responsible Parenthood and Reproductive Health law and its IRR, a Municipal Implementing Team (MIT) for the RPRH Law needs to be created;

**WHEREAS**, one of the key factors in disaster risk reduction and management is the efficiency of the evacuation center to cater to the needs of all affected populations during disasters;

**NOW, THEREFORE I, ELEGIO A. MALALUAN**, Municipal Mayor of Bongabong, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order the reorganization of the Municipal Implementing Team of the Responsible Parenthood and Reproductive Health (RPRH) Law in the Municipality of Bongabong, to wit:

**SECTION 1. COMPOSITION**

The Municipal Implementing Team of the RPRH Law shall be composed of the following:

## **SECTION 2. DUTIES AND RESPONSIBILITIES**

The Municipal Implementing Team of the RPRH Law shall have the following duties and functions:

- a) Design a program for the implementation of the RPRH Law at the municipal level, specifying the required technical, financial, and logistical support for its implementation;
- b) Ensure the integration of the RPRH Law in the function and activities of the agencies/organizations that they represent;
- c) Formulate policies necessary to promote the Programs on Population and Family Planning which will cater to the basic needs of both men and women in the municipality;
- d) Coordinate with agencies tasked to implement the RPRH Law and monitor its implementation at the municipal level, and;
- e) Provide the LCE with regular reports on the status of the implementation of the RPRH Law at the municipal level and come up with recommendations to address the gaps, if there be any;

There shall be a Secretary who shall be responsible for providing technical and administrative support to the Team, drafting the necessary letters/correspondence, documenting meetings and operation proceedings including photos, and researching and providing relevant/needed information to aid the Team.

## **SECTION 3. REPEALING CAUSE**

All rules and regulations, executive orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion thereof, are hereby repealed or modified accordingly.


## **SECTION 4. SEPARABILITY CLAUSE**

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

## **SECTION 5. EFFECTIVITY**

This Executive Order shall take effect immediately and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
