AN ORDINANCE DECLARING A PORTION OF THE MAGSAYSAY STREET, MARKET ROAD STREET & GOMEZ STREET IN BARANGAY POBLACION AS TRICYCLE TERMINAL

WHEREAS, pursuant to section 21 of RA 7160 or the Local Government Code of 1991 – Closure and opening of Roads (a) a Local Government Unit may, pursuant to an Ordinance, permanently or temporarily close or open any local road, alley, park, or square, falling within its jurisdiction.

WHEREAS, Section 3 (d) of Bongabong Municipal Ordinance No. 04 Series of 2006 titled “Codified Traffic Ordinance of the Municipality of Bongabong”, provides that No vehicles shall be allowed to use as terminal the streets within the Poblacion Area wherein Public Utility Vehicles are required to pass through unless granted by the Municipal Government the special permit to operate thereat a terminal or parking space or ***unless the space is officially declared as terminal or parking space by the Municipal Government.***

WHEREAS, a portion of Magsaysay Street, Market Road Street & Gomez Street in Barangay Poblacion, Bongabong, Oriental Mindoro, has long been used as a tricycle terminal to cater to the public, specially the elderly coming to and from the Public Market and clients coming to and from the Municipal Building.

NOW, THEREFORE, be it **ORDAINED**, as it is hereby **ORDAINED** by the Municipal Council of Bongabong, in session duly assembled:

SECTION 1. TITLE, – This Ordinance shall be known as the “Ordinance Declaring a Portion of the _ Magsaysay Street, Market Road Street & Gomez Street in Barangay Poblacion as Tricycle Terminal”.

SECTION 2. COVERAGE. – The Portion of Magsaysay Street with a length of 38 meters and 4 meters width, Market Road Street with a length of 12 meters and 4 meters width & Gomez Street with 18 meters length and 2 meters width in Barangay Poblacion,

this Municipality, approximately total area of 236 square meters is declared as Tricycle Terminal.

SECTION 3. DECLARATION OF POLICY. – The Municipal Government recognizes the need for an accessible and convenient public transportation for the general public, specially the elderly coming to and from the Public Market and clients coming to and from the Municipal Building.

SECTION 4. SEPARABILITY CLAUSE. – If, for any reason, any part of this Ordinance is invalidated by a Court of competent jurisdiction, the remaining portion of the Ordinance shall remain in full force and effect.

SECTION 5. REPEALING CLAUSE. – All other laws, decrees, orders, issuances, rules and regulations, which are inconsistent with the provision of this Ordinance, are hereby repealed, amended or modified accordingly.

SECTION 6. EFFECTIVITY. – This Ordinance shall take effect immediately upon its approval.
