MUNICIPAL ORDINANCE NO. 2020-10

AN ORDINANCE DESIGNATING A PORTION OF PLARIDEL STREET AND OF MARKET ROAD IN BARANGAY POBLACION AS PARKING AREA FOR PRIVATE VEHICLES

WHEREAS, there is no designated parking area for private vehicles in the market area, thereby resulting in traffic congestion;

WHEREAS, there is a need to address this problem to provide order and safety in the public market area;

NOW THEREFORE, be it enacted by the Sangguniang Bayan in session duly assembled that:

Section 1. Title. This Ordinance shall be known as the "ORDINANCE DESIGNATING A PORTION OF PLARIDEL STREET AND OF MARKET ROAD IN BARANGAY POBLACION AS PARKING AREA FOR PRIVATE VEHICLES" and shall hereafter be called "Ordinance":

Section 2. Parking Area. The road shoulders of Plaridel Street and of Market Road in Barangay Poblacion is hereby designated as parking area for private vehicles as follows:

- a. For four-wheeled vehicles the shoulder of Plaridel St. beside the municipal fence, opposite Buildings A, B and C of the public market;
- b. For motorcycles and tricycles both shoulders of Plaridel St. starting opposite of Building E of the public market up to corner Zamora St.
- c. Both shoulders of Market Road may be used for parking of motorcycles and tricycles.

Provided; that, the shoulder of Plaridel St. beside the Executive and Legislative Building, opposite Building D of the public market, shall be for TODA members;

- Section 3. Special Space for Senior Citizens, Pregnant Women and Persons with Disability. The Traffic Management Office shall designate a portion of Plaridel St. and of Market Road as special parking space for senior citizens, pregnant women and persons with disability.
- **Section 4. Prohibition**. It is hereby prohibited for any person to park his or her vehicle in a place other than those authorized in this Ordinance as parking area;
- **Section 5. Penalties**. The penalty for illegal parking shall be in accordance with the penalty prescribed under existing ordinance of the municipality;
- **Section 6. Enforcement**. The deputized traffic enforcers shall implement this Ordinance:

Section 7. Repealing Clause. Previous ordinance, rules or regulations issued by the municipal government that are inconsistent with the provisions of this ordinance are amended, modified or repealed;

Section 8. Separability Clause. If for any reason any portion of this Ordinance is declared unlawful or illegal, the portion not affected thereby shall remain in full force and effect:

Section 9. Effectivity. This Ordinance shall take effect upon approval and posting in three conspicuous places.
