MUNICIPAL ORDINANCE NO. 2024-04
 Series of 2024

BE IT ENACTED BY THE SANGGUNIANG BAYAN OF BONGABONG in session duly assembled:

Section 1. Short Title - This Ordinance shall be known as An Ordinance of Permanent Closure of An Alley in Barangay Aplaya, and shall hereafter be called Ordinance;

Section 2. Legal Basis - This Ordinance is enacted pursuant to the authority granted to the Sangguniang Bayan by virtue of Section 21 of RA 7160 which states in part that:

“Section 21. *Closure and Opening of Roads.* -

(a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.

(b) No such way or place or any part thereof shall be permanently closed without making provisions for the maintenance of public safety therein. A property thus permanently withdrawn from public use may be used or conveyed for any purpose for which other real property belonging to the local government unit concerned may be lawfully used or conveyed: Provided, however, That no freedom park shall be closed permanently without provision for its transfer or relocation to a new site.”

Section 3. Scope - This Ordinance covers the strip of an unnamed alley located in Barangay Aplaya passing between the houses of the Malapajo and Fadrigon and several other houses. This alley is depicted in the sketch prepared by the office of the municipal assessor and is identified and marked with distinct color. The sketch shall form an integral part of this Ordinance;

Section 4. Nature of Closure - The alley herein referred to is hereby permanently closed and is authorized to be waived in favor of the actual occupants who may apply title thereto subject to the approval of other government agencies;

Section 5. Maintenance of Public Safety - The officials of Barangay Aplaya shall be in charged of the maintenance of public safety therein;

Section 6. Separability Clause - If for any reason any provision or section of this Ordinance is declared illegal or unconstitutionally, other parts not affected shall continue to be in full force and effect;

Section 7. Effectivity - This Ordinance shall take effect upon approval and posting in the bulletin board of Barangay Aplaya and the bulletin board of the Municipal Building for two consecutive weeks.

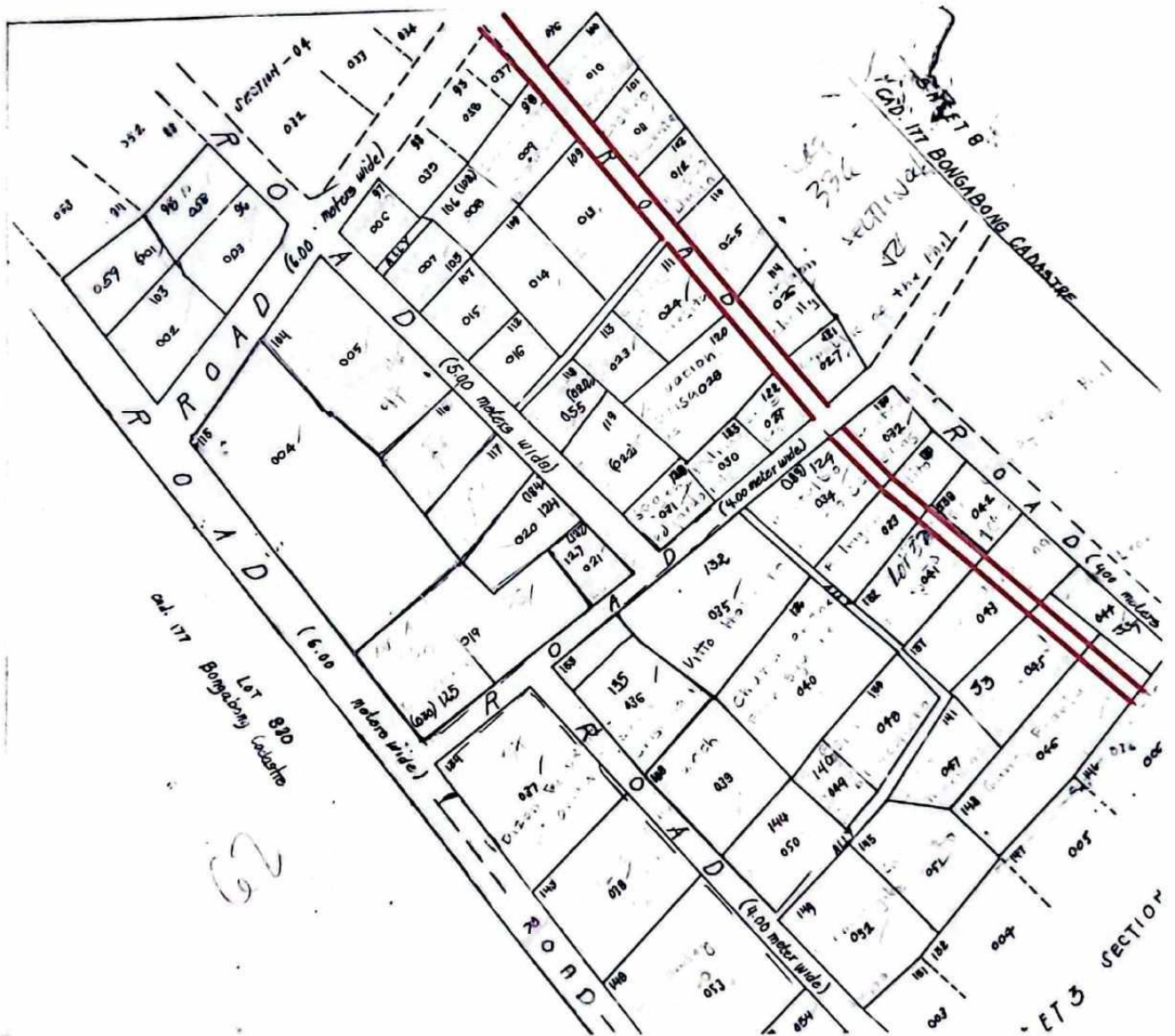
